



## MY FM TRIPLE TROUBLE TERMS AND CONDITIONS

### A. BASIC TERMS

1.	<b>Organiser</b>	Astro Radio Sdn Bhd (formerly known as Airtime Management & Programming Sdn Bhd)
2.	<b>Name of Contest</b>	MY FM Triple Trouble
3.	<b>Brief Description of Contest/ Programme</b>	This is a call in contest to give out cash prize!
4.	<b>Brief mechanism of Contest</b>	<p>The event will be promoted on-air.</p> <p>Announcers will prepare ten questions about current affairs on a daily basis and each question is worth RM10. However, if the listeners manage to answer ten questions correctly in a minute they will win RM1, 000.</p>
5.	<b>Eligibility Criteria</b>	<p>The Contest is open to all Malaysians who are aged 12 years old and above as at the Contestant's date of participation.</p> <p>Participants under the age of 18 years old must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in this Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest.</p> <p>The parents and/guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize(s).</p>
6.	<b>Ineligibility</b>	<p>The following persons are not eligible to participate in the Contest :-</p> <p>(a) Employees of the Organiser, Measat Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd (formerly known as Digital Five Sdn Bhd) and Astro Malaysia Holdings Berhad and their *immediate family members.</p> <p>(b) Has won any prize(s) up to a value either individually or collectively of a value of RM1000 and below from the Organiser in the thirty (30) days prior to entering the Contest;</p> <p>(c) Has won any prize(s) up to a value either individually or collectively of a value of RM1001 to RM5000 from the Organiser in the ninety (90) days prior to entering the Contest;</p> <p>(d) Has won any prize(s) up to a value either individually or collectively of a value of RM5001 and above from the Organiser in the one year (365) days prior to entering the Contest;</p> <p>*immediate family members means spouse, children, parents, brothers and sisters</p>
7.	<b>Age of Eligibility</b>	12 years and above as at the Contestant's date of participation.
8.	<b>Charges</b>	Standard telecommunication charges apply.
9.	<b>Contest Period</b>	Every week days from 4 February 2013 during "MY FM Breakfast" shift until the Entry Deadline

10.	<b>Language of Contest</b>	Mandarin or Cantonese
11.	<b>Entry Procedure</b>	Contestants need to listen to the cue to call and provide his/her name, NRIC, telephone number. Contestants must also agree with the Terms and Conditions of this contest before they participate in this contest.
12.	<b>Entry Deadline</b>	As determined by the Organiser.
13.	<b>Mode</b>	By calling in to MY FM 03-9543 3366 after hearing contest solicits.
14.	<b>Address</b>	All Asia Broadcast Centre, Technology ParkMalaysia, Bukit Jalil, 57000Kuala Lumpur
15.	<b>Selection of Winners</b>	The first caller who manages to answer the questions correctly.
16.	<b>Prize</b>	Contestant will win RM10 for each correct answer and if the Contestant manages to answer all ten questions correctly in a minute, the Contestant will win RM1,000 instead.
17.	<b>Notification of winners</b>	Winners will be informed right after answering the question by the announcers.
18.	<b>Collection Period</b>	The prizes will be given out within 90 days, after the contest.
19.	<b>Collection Venue</b>	The prizes will be sent to his/her via mail.
20.	<b>Additional Terms, if any</b>	<p>LINE DROP OUT AND INABILITY TO CONTACT</p> <p>Telephone Contests No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest :-</p> <ol style="list-style-type: none"> <li>a) a telephone line breaks up or drops out; or</li> <li>b) there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>c) two telephone lines are crossed during a phone in Contest;</li> </ol> <p>the Organiser may in its absolute discretion disqualify the relevant caller or callers, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person according to its absolute discretion.</p> <p>In the event that more than one voice is heard on the phone line, the qualifying Contestant or Winner will be the first person to speak. If the judge(s) is not able to determine which caller was first, a random drawing will be held to determine the Winner.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet.</p>

The Basic Terms and **the Contest Standard Terms and Conditions** (collectively "Terms and Conditions") shall be binding on all contestants who participate in this Contest ("Contestants"). The definitions in the Contest Standard Terms and Conditions shall apply unless otherwise expressly stated in the Basic Terms. In the event of any inconsistency between the Basic Contest Terms and the Contest Standard Terms and Conditions, the Basic Terms shall prevail to the extent of such inconsistency.

Entry and participation in the Contest shall be deemed an unconditional acceptance by the Contestants of the Terms and Conditions
