



## Mind Trap on hitz TERMS AND CONDITIONS

### A. BASIC TERMS

1.	<b>Organiser</b>	Astro Radio Sdn Bhd
2.	<b>Radio Station</b>	hitz fm
3.	<b>Name of Contest</b>	Mind Trap on hitz
4.	<b>Brief Description of Contest/ Programme</b>	This is a call in contest to give away a minimum of RM 100 cash prize.
5.	<b>Brief mechanism of Contest</b>	<p>The first two (2) callers through after the cue to call will have to strike a conversation with the announcers, Jay, Arnold or RD for 60 seconds without mentioning the 3 words of the the day. The 3 words of the day will be decided by the hitz morning crew daily and will only be mentioned at the start of the contest segment. However, the callers will not be aware of the 3 words for the day as it will only be mentioned to the listeners. In addition to that, the throughout the conversation, the callers –</p> <ul style="list-style-type: none"><li>(1) cannot fumble throughout the conversation;</li><li>(2) cannot stale when answering and their answers need to make sense. If the caller is able to keep the conversation going for 60 seconds, the caller wins RM 100 or more, depending on snowball amount. If the first two (2) caller fails, money will snowball to the next contest segment.</li></ul>
6.	<b>Eligibility Criteria</b>	<p>The Contest is open to all who are aged 12 years old and above as at 19th December 2016.</p> <p>Contestants under the age of 18 years old must obtain the consent of his/her parent or legal guardian in order to be eligible to participate in this Contest and to receive the Prize. The Organiser considers it the responsibility of parents and/or guardian to monitor their children's participation in this Contest.</p> <p>The parents and/or guardian may at the absolute discretion of the Organiser be required to sign an indemnity in the form required by the Organiser as a precondition to their child's entitlement to the Prize(s).</p>

9.	<b>Charges</b>	Standard telecommunication charges apply.
10.	<b>Contest Period</b>	19 <sup>th</sup> December 2016 till 18th December 2017.
11.	<b>Language of Contest</b>	English
12.	<b>Entry Procedure</b>	Be the first two (2) callers through after the cue to call
13.	<b>Entry Deadline</b>	18th December 2017.
14.	<b>Mode</b>	By calling hitz.fm's telephone number – 03 9543 3311
15.	<b>Address</b>	All Asia Broadcast Centre, Technology Park Malaysia, Bukit Jalil, 57000Kuala Lumpur
16.	<b>Selection of Winners</b>	The first two (2) callers through and thereafter successfully complete the conversation in 60 seconds without breaking the rules as stated above in (Section 5)
17.	<b>Prize</b>	Minimum of RM 100 cash prize.
18.	<b>Notification of winners</b>	Winners will be informed right after the on air contest.
19.	<b>Collection Period</b>	Cash Prize – within one month from date of winning
20.	<b>Collection Venue</b>	To be delivered accordingly to the winner's respective address.
21.	<b>Additional Terms, if any</b>	<p><b>In the event the Winners require reissuance of cheque for the Prize, RM50.00 will be deducted from the value of the Prize unless such reissuance is due to the negligence, omission and/or fault of the Organiser.</b></p> <p>LINE DROP OUT AND INABILITY TO CONTACT***</p> <p>Telephone Contests No liability is assumed by the Organiser for faulty, mistranscribed, misdirected/misdialled telephone communication or technical difficulties experienced by callers throughout the call-in portion of a Contest.</p> <p>If in the course of a Contest :-</p> <ol style="list-style-type: none"> <li>a telephone line breaks up or drops out; or</li> <li>there is a dispute arising out of the use of telephone lines in a Contest (including situations where multiple telephone lines are used); or</li> <li>two telephone lines are crossed during a phone in Contest;</li> </ol> <p>The Organiser may in its absolute discretion disqualify the relevant caller or callers for any reason whatsoever, and shall not be responsible for awarding a Prize to the relevant caller or callers, and may award the Prize to another person, at its sole and absolute discretion.</p> <p>In the event that a voice other than the caller's (or Contestant's) is heard on the phone line, the qualifying Contestant or Winner will be the first person on the phone line to speak. If the judge(s) is not able to determine which caller was the first to speak on the phone line, a random drawing will be held to determine the Winner, and the outcome of the draw will be final.</p> <p>Any entries which are found to have used telephone switching or programming equipment shall be disqualified.</p> <p>In telephone Contests, "sonic triggers" are effective only when heard on on-air radio broadcast, and internet streaming shall not be valid as there may be delays in audio transmission or errors on the internet.</p>

The Basic Terms and **the Contest Standard Terms and Conditions** (collectively "Terms and Conditions") shall be binding on all contestants who participate in this Contest ("Contestants"). The definitions in the Contest Standard Terms and Conditions shall apply unless otherwise expressly stated in the Basic Terms. In the event of any inconsistency between the Basic Contest Terms and the Contest Standard Terms and Conditions, the Basic Terms shall prevail to the extent of such inconsistency.
