4.	<b>Brief Description of Contest/ Programme</b>	This is an online contest to give away movie preview passes to watch <i>WONDER WOMAN</i> .
5.	<b>Brief mechanism of Contest</b>	<p>The Contest will be promoted on air, online, social media and on-ground.</p> <p>Log on to my.com.my to take part in the contest by answering one simple question and complete a slogan.</p> <p>The participants who answer the question correctly and provide the slogan in the most creative way, as determined by the organiser in its sole and absolute discretion, will win 4 movie preview passes to watch <i>WONDER WOMAN</i>.</p>
