A. BASIC TERMS

1.	Organiser	Astro Radio Sdn Bhd
2.	Radio Station	THR Raaga
3.	Name of Contest	THR Raaga, Agenda Suria Communication- udan Inanithu Vazhanggum Kandupidicha Kaasu @ Midvalley Convention Centre
4.	Brief Description of Contest/ Programme	Be the first to register to play games during the event. Games will have elimination rounds till left with only top 3 participants (finalists) The 3 finalists must guess the item in the box within 10 secs. Finalist with the right answer will win. If more than one answered the correct answer – they will need to go through a tie breaker. Only 1 winner for each contest segment. This contest will run for 3 days (3 times a day)
5.	Brief mechanism of Contest	On air solicit 1 hour before the registration. Listeners need to go to Midvalley Convention centre to register themselves as the first 10 participants. From 10 participants, we will eliminate 4 participants with a game. Followed by another 3 elimination with a different game. Final 3 participants will be playing what's in the box guessing game, each will be given 10 seconds to feel the item in the box and write down what the item is. 3 of them will flash the answer at the same time. Finalist who flashes the right answer wins. If more than 1 finalist flashes the same answer – they have to go through a tie breaker game.
6.	Eligibility Criteria	The Contest is open to all Malaysians who are aged 18 years old and above as of 1 st May 2017
7.	Ineligibility	The following persons are not eligible to participate in the Contest :- (a) Employees/contractors/vendors of the Organiser, the sponsor(s) of the Contest, MEASAT Broadcast Network Systems Sdn Bhd, Astro Entertainment Sdn Bhd, Astro Production Sdn Bhd, Astro Digital 5 Sdn Bhd and Astro Malaysia Holdings Berhad and their *immediate family members. (b) Has won any prize(s) up to a value either individually or collectively of a value of RM1000 and below from the Radio Station in the thirty (30) days prior to entering the Contest. (c) Has won any prize(s) up to a value either individually or collectively of a value of RM1001 to RM5000 from the Radio Station in the ninety (90) days prior to entering the Contest.
